Chart of Accounts

The following new features have been added to the General Ledger Chart of Accounts form:

- Choose to create one new account, or create many new accounts at a time.
- Duplicate or copy an existing chart of account. You can modify one of the segments to create a new set of accounts.

Reports

Description The following new features have been added to General Ledger reports.

Report Ranges	The Ranges field has been expanded show all values for a range. In addition, you can also use the zoom lookup feature to select a range for the report.
General Led- ger and Work- ing Trial Balance	The report parameters window now offers lookup capabilities by Journal Code. This feature gives you the ability to produce a balance sheet that excludes specific journal types and is particularly useful at period end or year end when you want to see a trial balance excluding audit or tax adjustments in order to reconcile your records to the company closing or opening balance.
AP Vendor Subledger	This new general ledger report displays gain or loss for each vendor payment amount.
AR Customer Subledger	This new general ledger report displays gain or loss for each customer payment amount.

Introduction The following section lists issues identified in General Ledger since version 7.2.

Company Definition

When entering a company definition in the Company Definition window, using ctrl+z to open the zoom lookup feature is not working. The system permits the lookup, but the company definition will not save. (SCR 28600)

Workaround: Manually enter company definitions.

Post Standard Transactions

When selecting a specific journal type using the zoom lookup feature, the Control Number list is not filtered. All journal entries appear in the list. (SCR 29653)

Shipping Terms

DescriptionYou cannot enter new Shipping Terms codes in Accounts Receivable without a
Delivery Code. (SCR 30174)Workaround: Enter a Delivery Term in the General Ledger - Intrastat folder.

Reports

Transaction Edit Report The Transaction Edit Report that prints during the GL Standard Transaction Posting process shows all transactions, even if they are not included in the filter options. (SCR 30243)

Workaround: Modify report criteria in Crystal Reports to display the desired journal entries.
